Rules and Regulations/Guidelines for field work /educational excursion/Industrial Training/Mine visit, Asutosh College, Kolkata (affiliated to University of Calcutta)

Asutosh College aims to promote and encourage experiential learning through multiple avenues. To make education holistic, the college organises field trips, industry visits and study tours as an extension of theoretical learning and to expose students to new and unique real-world experiences. Field Works are compulsory papers in some subjects, abstaining from which a student fails to clear the semester examination.

- 4. Consumption of alcohol and any other intoxicating substance is strictly prohibited.
