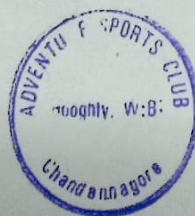

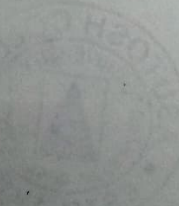

Article 1

OBJECTIVE OF COLLABORATION

The objective of this Memorandum of Understanding (MOU) is to collaborate with each other in extra-curricular activities in areas of mutual interest.

Article 2

SCOPE OF COLLABORATION

The Parties agree to implement collaborative programmes including but not limited to:

- a. Hosting of Nature Study camps and Adventure camps.
- b. Rock climbing with certificate.
- c. Trekking in mountains/ jungles/ along the coast.
- d. Organization of workshops.
- e. Artificial Wall climbing.

Article 3

FINANCIAL ARRANGEMENT

Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authority/authorities. The college undertakes to finance the cost for a minimum of 30 students for each program.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Asutosh College (Main Campus and Second Campus) and at various sites within and outside the state of West Bengal.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

All programmes will be offline.

Article 6

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the institutions shall respect and retain confidentially in each/ any of the collaborative efforts, and all collaborative exercises shall be guided, directed and implemented by the greater academic interest of both the institutes, and not any other / commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 7

DURATION AND TERMINATION

1. This MOU shall enter into force on the date of signing.
2. The MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
3. Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
4. The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 8

AMENDMENT

1. This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
2. Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

Article 9

SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.
