Article 3

FINANCIAL ARRANGEMENT

Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authority/authorities.

Article 4

LOCATION OF ACTIVITIES

- The Parties agree to implement the programmes stated in Article 2 at Asutosh College and Alipurduar Mahila Mahavidyalaya.
- Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

Article 6
