Article 2

Article 3

FINANCIAL ARRANGEMENT

Any collaboration under this Memorandum of Understanding is subjected to the availability of funding sources and approval of the relevant authorities.

Article 4

LOCATION OF ACTIVITIES

- The Parties agree to implement the programmes stated in Article 2 at Asutosh College and Brahmananda Keshab Chandra College.
- 2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted in blended mode (offline and online).

Article 6

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 7

DURATION AND TERMINATION

- 1. This MOU shall enter into force on the date of signing.

- 4. The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 8

AMENDMENT

- 1. This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2. Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

Article 9 SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.
