#### Article 3

#### Article 4

#### LOCATION OF ACTIVITIES

- The Parties agree to implement the programmes stated in Article 2 at Asutosh College and Deshabandhu Mahavidyalaya.
- 2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.
