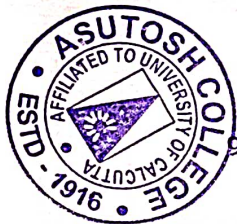
However, the fees charged from the students to run the courses will be decided after mutual discussion between ASUTOSH COLLEGE and RKMVM.

5. **RESPONSIBILITY OF RKMVM**

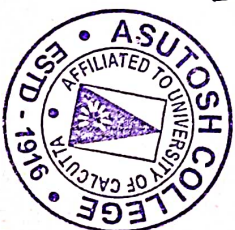

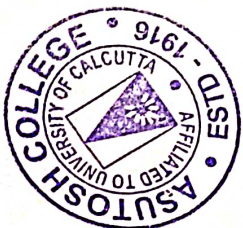
Neither RKMVM nor ASUTOSH COLLEGE shall be held responsible for non-fulfillment of their respective obligations, under this agreement, due to the exigency of one or more of the force majeure events such as but not limited to acts of God, War, Flood, Earthquakes, Strikes, Lockouts, Epidemics, Riots, Civil Commotions etc. provided, on the occurrence and cessation of any such event RKMVM affected thereby, shall give a notice in writing to ASUTOSH COLLEGE within one month of such occurrence or cessation. If the force majeure continues beyond six months, the parties shall jointly decide about the future course of action.

8. **TERMINATION OF AGREEMENT**

This agreement may be terminated by either of the parties forthwith if either RKMVM or ASUTOSH COLLEGE commits breach of any of the terms hereof and shall have failed to rectify such breach within thirty days of the notice served on it by the other party i.e. either RKMVM or ASUTOSH COLLEGE, in correspondence; as the case may be.

In addition to the reasons for termination as set forth above, this agreement may be terminated forthwith if either of ASUTOSH COLLEGE and RKMVM voluntarily or involuntarily enters into official dilution, bankruptcy or similar recognizable

9. **DURATION**

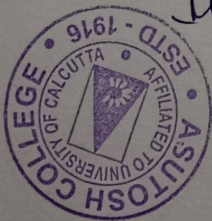
This 'Memorandum of understanding' shall remain valid for a period of 2 years only from the date of signing the MOU by the authorized signature of each party. After this 2 years' period, this MOU may be terminated or may be renewed after judging the-then situations.

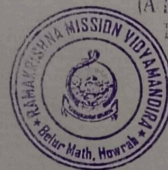

confidence, as per clause 5 above; accrued on or prior to the date of such termination, make written reports and keep records, files and books and the right of RKMVM to inspect the same.

11. **NOTICES**

All notices and other communications required to be served on RKMVM, under the terms of the agreement, shall be considered to be duly served, if the same shall have been delivered to, left with or posted by registered mail to RKMVM at its last known address of business. Similarly, any notice to be given to the ASUTOSH COLLEGE, shall be considered to be duly served if the same shall have been delivered to, left or posted by registered mail to the ASUTOSH COLLEGE at its registered address in Kolkata.

12. **AMENDMENTS TO THE AGREEMENT**

12.1 No amendment or modification of this MOU shall be valid unless the same is made in writing by both ASUTOSH COLLEGE and RKMVM or their authorized representatives and specifically stating, the same to be an amendment of this MOU. The modifications/changes shall be effective, from the date on which they are made/executed; unless otherwise agreed to. In

13. **ASSIGNMENT OF THE AGREEMENT**

13.1 The rights and/or liabilities to RKMVM to this MOU shall not be assigned except with the written consent of both ASUTOSH COLLEGE and RKMVM, subject to such terms and conditions; as may be mutually agreed upon, by both ASUTOSH COLLEGE and RKMVM.

14. **ARBITRATION**

14.1 Except as hereinbefore provided, all disputes arising out of or in connection with this MOU shall be referred to the sole arbitration of a person nominated by Director-General, CSIR and designated as the Arbitrator. The arbitrator's verdict shall be final and binding on both ASUTOSH COLLEGE and RKMVM. From time to time, with the consent of both ASUTOSH COLLEGE and RKMVM, the Arbitrator may enlarge the scope and time for making and publishing the verdict awarded.
